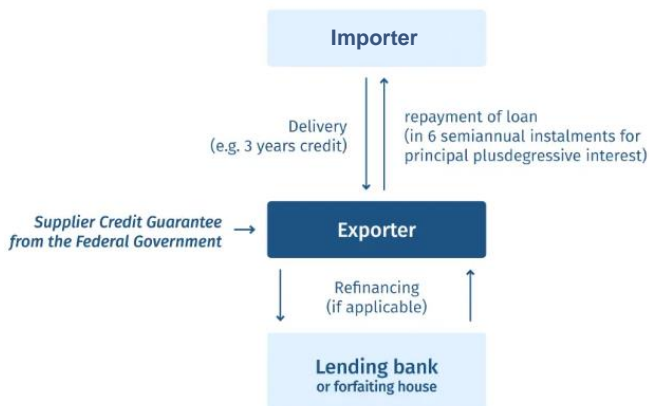

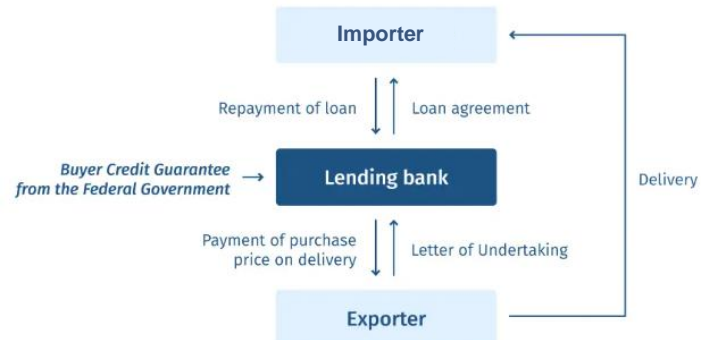
SUPPLIER CREDIT

With supplier credit, the exporter grants the importer a loan. Under a Supplier Credit Guarantee, the Federal Government covers the associated risks and thus enables a bank to purchase the receivable.



BUYER CREDIT

With a buyer credit, a bank grants the importer a direct loan for an export transaction. This is a tied buyer credit as the credit or loan is used solely to finance this export transaction.
